## Darts Regulation Authority extends partnership with Sportradar Integrity Services

The Darts Regulation Authority (DRA) and Sportradar Integrity Services – a global supplier of sports integrity solutions – have entered a multi-year agreement for the bet monitoring of Professional Darts Corporation (PDC) events.

Throughout the agreement, all PDC tournaments, including events such as the World Championship, Premier League, Challenge Tour events and Q School will be monitored by Sportradar Integrity Services via their Universal Fraud Detection System (UFDS). Sportradar already provide services to DRA to support disciplinary investigations into betting-related matters.

We already work with Sportradar's Intelligence and Investigation Services on integrity matters, and they have provided valuable support during past investigations. With the extension of this partnership through the UFDS, we will have visibility over global betting activity across all levels of darts, and this help will help to support the healthy growth of our game."
